
## 2.2 AN EASY TRAVEL HUB FOR INTERNATIONAL PARTICIPANTS

# 3. HOW THE 2017 WORLD SCHOOLS DEBATING CHAMPIONSHIP IS TO BE HELD IN BALI

#### 3 1 ACCOMMODATION

The Swiss Belhotel, Watu Jimbar, Sanur, Bali would be the main hotel to accommodate all the delegations of the 2017 World Schools Debating Championship. It is situated in the tranquil area of Sanur, which has beautiful white sands. The Swiss Belhotel is a four-star hotel that can best serve the championship's needs in one of the best areas in Bali.

The hotel offers 24-hour room service, laundry and dry cleaning, Wi-Fi Internet connection in all rooms and public

areas, parking spaces and valet parking service and 24-hour security with CCTV cameras.

#### 3.3 GENERAL FACTS

Bali has a tropical climate appropriate to its proximity to the equator. Year-round temperatures average 31 degrees Celsius. High humidity can be expected during the rainy season between the months of October and April. The dry season between the months of May and September has the lowest humidity. The wet season brings daily rain and overcast days with the most rain recorded between December and February. Occasionally rainfall can also be expected during the dry season. From June to August there is usually a very refreshing cool breeze all day long.

The most suitable things to wear are light clothes in natural, breathable fabrics. Work on wearing two outfits a day: one throw-over type of dress or a shorts/light top combination and something casual/smart during the competition. Don't forget to bring along your swimsuit. SPF 30+ or 50+ sun-screen is a must.

### 3.4 AN EXPERIENCED ORGANIZING COMMITTEE

Four members in our core team (all three proposed co-convenors and the tournament director) have previously participated in the WSDC in various capacities. Furthermore, the majority of our members are also experienced at running the Indonesian Ministry of Education-National Schools Debating Championship, which mirrors the WSDC in various aspects (e.g., the WSDC adjudication system, schools rotation system, cultural immersion program, excursions, breaking night party, cultural immersion program, the use of three- to five-star hotels and much else). As a team, we have collectively worked with ministry officials, provincial governments, media, school authorities and police officers, as well as teachers and students from all 34 provinces in Indonesia.










#### Highlight of events:

#### **Opening session**

The opening session will be held in Taman Baghawan, a culturally inspired beachfront venue. An outdoor function combining traditional Balinese culture and haute-cuisine with a uniquely memorable setting will be prepared to welcome all the delegates. The welcoming "Pendet" dance would be performed as the main entertainment.

#### **Closing session**

The final round and the closing session will be held in Garuda Wisnu Kencana (GWK) in the Ungasan area, about a 20-minute drive from Sanur. The best sunset view with the giant statue of the god Vishnu in the background, will provide you with most memorable event during the World Schools Debating Championship. Balinese fine dining will also be offered, as well as the best Barong Dance to enjoy the night before leaving Bali.



#### 3.6 A COMMITMENT TO PRESERVE THE ENVIRONMENT

Our team recognizes the importance of preserving the environment and we believe that every little action counts. At this point in time, we are planning to impose a "No Water Bottle" policy. We are going to provide several dispensers at our venues and give a tumbler to each participant, so that we will significantly minimize, if not eliminate, the use of bottled water during the tournament.

#### 3.7 FRIENDLY VISAS POLICY

Foreign passport holders entering Indonesia must possess a passport that is valid for a minimum of 6 (six) months from the date of arrival. Delegates are advised to check if they require a visa based on the type of passport, as follows:

#### Visa free

Tourists holding passport from the following 45 countries and territories are eligible to enter and remain in Indonesia without a visa for 30 days. The visa free facility does not allow the change into other permits or visa extension. See under rules for different rules that apply regarding the port of entry and purpose of stay depending on the nationality of the visitor.

#### Visa on Arrival (VoA)

Nationals of the following 33 countries may apply for a Visa on Arrival for a length of stay of 30 days by paying US\$35 at major entry points.

#### **Visa Before Arrival**

Nationals who are not eligible for visa free or VOA need to apply the visa at Indonesian embassy or consulate. Nationals of San Marino require visa at all times including for transit. Otherwise other nationalities can transit through Indonesian airports for up to 8 hours.

Nationals of below countries require an approval from Immigration Office in Indonesia before travelling for Business, Tourist and Social Visits purposes. This policy is called Indonesian Calling Visa.

#### PROPOSED CO-CONVENORS

#### **Muhammad Subarkah Syafruddin**



Subarkah has been the head coach and team manager of Team Indonesia every year since WSDC 2012. Under his leadership and guidance, Indonesia managed to enter the octo-final round and one speaker managed to clinch the First Best EFL Speaker Award in 2014 in

Thailand. In 2013, Indonesia also managed to clinch the Best EFL Team Award.

Subarkah is passionate about mainstreaming the WSDC format in Indonesia. As the appointed Chief Adjudicator and/or Project Officer of Indonesia Ministry of Education-National Schools Debate Championship since 2012.

He has closely worked with the Ministry of

Education, provincial governments and host schools, as well as with teachers and students from all 34 provinces in Indonesia. Subarkah has also worked for top law firms in Jakarta and for Strategic Planning, Monitoring & Evaluation and Gender units at the Indonesia Country Office of the United Nations Population Fund, where he oversaw and evaluated the UN's work with the Ministry of Health, the Ministry of Women Empowerment and Child Protection, the National Commission on Violence Against Women and the State Ministry of National

Development Planning.

Subarkah was an active competitive debater for Universitas Indonesia as an undergraduate. He was the Grand Champion of the Australasian Intervarsity Debating Championship in 2011 in Seoul (ESL Category). Besides debating, Subarkah was an avid international law moot court participant with various national and international titles under his belt. For his academic excellence and extra-curricular activities, Subarkah was named "Indonesia's Most Outstanding Student For the World" by the Ministry of Foreign Affairs in 2012.



#### Kristi Ardiana

Kristi is an undergraduate student at Universitas Indonesia, majoring in law. She started her debating career in her high school in 2010. As early as her freshman year, Kristi was named the 7th Best EFL Speaker at the United Asia Debating Championship and snatched the

first runner-up position of the Asian English Olympics 2015.

Not only is Kristi an active debater, she also contributes heavily to Indonesia's debating community as adjudicator and coach. Kristi was the chief adjudicator of the Asian Law Students' Association (Local Chapter Universitas Indonesia) Debating Championship, one of the largest debating competitions for high school and varsity

students in Indonesia. More recently, Kristi was also the Deputy Chief Adjudicator of the Indonesia Ministry of Education-National Schools Debating Championship, the only competition in Indonesia that uses the WSDC format. She was also the Project Officer of the "Founders Trophy" in 2013, the first national BP debate tournament in Indonesia. She is currently attending WSDC 2015 as an official adjudicator with Team Indonesia.

Besides being active in Indonesia's debating community, she's also an activist who works for youth empowerment. She has had considerable experience in organizing big national events in Indonesia. She was on the external division committee for the International Youth Camp: Indonesian Music Mission Festival 2014. She also conducted several youth empowerment activities in collaboration with government officials and volunteered as a contributing writer for Voices of Youth UNICEF in 2014.



#### **Alif Azadi Taufik**

Taufik is an undergraduate student at Universitas Indonesia, majoring in management. He is currently an active member of the Universitas Indonesia English Debating Society. As a debater, Alif has won the Java Overland Varsity English Debate Competition 2015 and English Challenge - Asian Law Students' Association (Local Chapter Universitas Padjajaran) 2015. Alif also attended WSDC 2014 when his team broke into the knockout round. Individually, Alif was named the 6th Best EFL Speaker.

Alif was a Liaison Officer at the Indonesian Ministry of Education (National School Debating Championship) in 2014. Subsequently, he became an Invited Adjudicator at the Ministry of Education-National University Debating Championships – Regional Selections for West Java and Banten provinces in 2015. Furthermore, he was the Tournament Director of the Founder's Trophy in 2014.



#### PROPOSED TOURNAMENT DIRECTOR

#### Regina Cara Riantoputra

Cara is a second-year Economics student at Universitas Indonesia. She was a member of Team Indonesia in WSDC 2014, the first Indonesian team to break into the elimination rounds since 2003. She also bagged the award for 1st Best Speaker in the EFL category. Cara has been an active member of the Indonesian debate community since her high school years, winning multiple regional and national debate tournaments, and recently winning two of Indonesia's biggest varsity championships. In her first year of university, she has adjudicated in several top national debate tournaments, including the Indonesian Ministry of Education's NSDC (National Schools Debate Championship; the Indonesian selection tournament for WSDC).

In her short time, Cara has had considerable experience in organizing national debate tournaments. She currently dedicated her time to the Board of Executives of English Debating Society Universitas Indonesia (EDS UI) - Indonesia's oldest debating community and one of the most prestigious - in the Tournament Division, where she organizes all of EDS UI's internal and external tournaments. She has also organized several top national high school competitions as head of committee.



#### PROPOSED FIELD OFFICER

#### **Rahmat Nugraha**

Rahmat Nugraha is a senior year student at Universitas Indonesia on a full-merit based scholarship from the provincial government of Aceh. As a student, he is actively involved in debating and the Model United Nations. He is the former secretary-general of the Universitas Indonesia Model United Nations Club.

Rahmat was the champion and the 9th Best Speaker of the Indonesian Ministry of Education-National Schools Debating Championship in 2011. Because of his attachment to this championship, Rahmat came back as the field officer of the 2014 championship. Following his success, he was then entrusted to serve as the project officer of the following year's championship.

Other than debating, Rahmat also has several awards under his belt. He received an international scholarship awarded by Victoria University of Wellington to attend the annual Asia Pacific Model University Conference. He also held a notable position for directing the simulation of the United Nations Environment Programme at Nanyang Technological Model United Nations 2015 in Singapore. He was also the Director of the International Conference of Economix in Indonesia in 2014.

For his international exposure, extensive organizational and leadership activities, Rahmat was also named the Student with Most Potential by the Faculty of Economics, Universitas Indonesia for two consecutive years. These are also reasons why he would be a competent field officer of WSDC 2017.

#### **Kip Oebanda**

WSDC Singapore will be Kip's seventh WSDC. He coached the Philippine national team thrice. He was a member of the Chief Adjudication Panel of Cape Town and Turkey and judged three grand finals. He was also a member of the Motions Committee thrice. He has extensive experience in handling international tournaments. He was Chief Adjudicator or a member of the Chief Adjudication Panel of numerous tournaments:

including Eurasians Debating Championship 2014 and 15, Asian Schools Debating Championship - Korea, Philippine Schools Debating Championship - Philippines Thailand World Schools Debating Championship, Philippine Intervarsity Debating Championship.

As a debater, he was active in the Asians and Australs circuit. He broke third and got to the semifinals of Australsian Intervarsity Debating Championship (Main Break Category). He was also the third best speaker of Asia in 2005. He has also won 17 regional and national tournaments and was awarded the joint Best Judge of Asia at the United Asians Debating Champions in 2013 and the Best Judge of the Philippines twice. His day job is working in a non-profit saving women and children from trafficking. He also directs movies.

#### Mia Rubianti

Mia Rubianti is currently a corporate engagement manager at The Jakarta Post Foundation. Her role is to bring together all of the stakeholders in the community involved in education improvement through the Newspapers in Education (NIE) program. Mia has remained very actively involved with student debating in Indonesia since 2009 and she now conducts regular English debates among school students. Her first introduction to debating occurred when she served as project officer for an English competition named Youth Speak Fun Day (YSFD). YSFD was held in 11 provinces and involved around 40,000 students in Indonesia. On 2014, YSFD won the top award in the "Playing with News" category of the World Young Reader Prize competition organized by the World Association of Newspapers and News Publishers. Mia also served as project officer for hosting The 2014 World Young Reader Summit in Bali. #### Anies Baswedan, PhD

#### Culture and Elementary and Secondary Education Minister

Even before his appointment as Indonesia's culture and elementary and secondary education minister, Anies Baswedan was well-known as a public expert on education. He was one of the youngest university presidents and considered young intellectual. In 2008, Anies was named by US Foreign Policy magazine as one of the top 100 public intellectuals in the world. The Japanese magazine Foresight included him on a list of 20 names (from all continents) to be watched over the next 20 years, along with names such as Vladimir Putin (Russia), David Miliband (UK), Hugo Chávez (Venezuela) and Rahul Gandhi (India). The World Economic Forum included him in the 2009 Young Global Leaders list, while the Royal Islamic Strategic Studies Center listed him among the 500 most influential Muslims in the world.

Anies graduated from Gadjah Mada University, majoring in economics, in 1995. When he was a student at the university, he was awarded the JAL Scholarship to attend a summer session of Asian studies at Sophia University in Tokyo. A year after completing his study at Gadjah Mada University, Anies was awarded a scholarship to pursue a Master's degree in international security and economic policy at the University of Maryland, College Park, in the US. When he was a college student, he received the William P. Cole III Fellowship from the Maryland School of Public Policy, an ICF scholarship and an ASEAN Students Award. Following the completion of his Master's program, he received a Fulbright Scholarship, as 2004 Gerald Maryanov Fellow at Northern Illinois University, also in the US. His academic paper discussed "Regional autonomy and democratic patterns in Indonesia".

In senior high school, Anies began to understand the importance of competency at the international level. In 1987, he was selected as a participating student in the Bina Antar Budaya Award (AFS Indonesia), a student exchange program between Indonesia and the US.

Despite his tight schedule, Anies initiated INDONESIA MENGAJAR (Teaching Indonesia) in 2010, a movement that sends educated youth to teach at elementary schools in remote areas of the country for one year. The movement also aims to shape leadership candidates who have first-hand experience of grassroots issues.

Anies also initiated INDONESIA MENYALA (Lighting Up Indonesia) as a follow-up initiative to INDONESIA MENGAJAR with the objective of fostering a love of reading among Indonesian children and promoting a reading culture. Anies also motivates professionals to teach through his movement KELAS INSPIRASI (Inspiring Class), with the primary goal of motivating children to reach their dreams.

Jusuf Wanandi is Senior Fellow and co-founder of the Centre for Strategic and International Studies (CSIS), and Vice Chairman of the Board of Trustees CSIS Foundation, Jakarta. He is Vice Chair of the Indonesian National Committee for the Pacific Economic Cooperation Council (INCPEC), Co-Chair of the Pacific Economic Cooperation Council (PECC), and Co-Chair of the Council of Security Cooperation in Asia Pacific (CSCAP), Indonesia.

He is also President Director of the publishing company of The Jakarta Post Daily as well as Chairman of the Board of the Prasetiya Mulya Business School, and Chairman of the Foundation of Panca Bhakti University in Pontianak, West Kalimantan.

A lawyer by training, Mr. Wanandi was assistant professor of law at the University of Indonesia, and has served in various national and international organizations in the course of his career. He was appointed as Secretary of the Indonesian Supreme Advisory Council; Secretary General of the National Education Council; and as four-term representative in the People's Consultative Assembly. He was active in the Golkar Party between 1979 until 1988 as a member of the Central Board in various capacities.

He has written extensively in national and international magazines and newspapers and has edited a number of books on political and security developments in the Asia Pacific region.

### Involvement and support from the Indonesian Ministry of Eduction

The Ministry of Education of Indonesia and other government officials are committed to supporting the proliferation of debate in Indonesia. That is proven by their commitment to conduct and give full funding for the National Schools Debating Championship (Indonesia's selection phase for WSDC candidates that adopted the WSDC format and system) since 2001. Internationally, the Ministry has hosted the International Biology Olympiad, International Earth Science Olympiad, International Astronomy Olympiad, International Conference of Young Scientists to name but a few.



### **FINANCIAL MATTERS**

We acknowledge that adjudicators are an essential part of the WSDC. We understand that all WSDC participants from all over the world already practice so hard to prepare their best for the competition. Therefore, we want to show our commitment to invite more adjudicators to make sure all participants get the best quality adjudication. With this policy we also wish to give more opportunity for those individuals who want to get involved in the WSDC as adjudicators. We are happy to announce that we are planning to invite 30 adjudicators (10 adjudicators will get full subsidies for flights and accommodations and 20 will get partial subsidies for their accommodations).

The registration fee is relatively low. We acknowledge that many teams experience financial hardship to

attend the WSDC on an annual basis. To help alleviate that, we are committed to charging a relatively lower registration fee.

The registration fee that we can confirm at this point in time in Indonesian rupiah (IDR) for debaters, coaches, adjudicators and team managers will be <u>IDR 9 million</u> <u>per person (approximately US\$599, €543, or £389)</u>.
